2023 Rules & Regulations

Fair Dates: August 30 – September 4, 2023

PLEASE RETAIN A COPY OF THESE RULES & REGULATIONS FOR YOUR REFERENCE.

- **\$50 Non-Refundable Deposit is Due Upon Receipt of this Contract.** Payment in Full is due by January 1 to reserve your space; otherwise, it may be reassigned to a different vendor. **PAYMENT IN FULL IS DUE BY APRIL 15 TO AVOID A \$50 LATE FEE.** Returned check fee is \$50. Cancellations are subject to partial refunds depending on date of cancellation; see your contract for details.
- **Only products listed on your vendor application and approved by the Fair Board may be sold.**
- **All vendors must provide for their own beverage supply and coolers as needed.** Vendors must specify all items to be sold and they must be approved by the Board. **THE STONEBORO FAIR RETAINS EXCLUSIVE RIGHTS TO SELL OR DISTRIBUTE STONEBORO FAIR MEMORABILIA, INCLUDING APPAREL.**
- **Contracts do not allow subletting of space nor are they transferable.**
- Unless indicating on your contract that you would like to purchase insurance through the Fair, all concessionaires must present Proof of Insurance listing the Great Stoneboro Fair as **ADDITIONALLY INSURED BEFORE JUNE 1ST.**
- **Concessions must be set up by 3 pm on Wednesday, August 30th.** Tear down time will begin at 10 pm Labor Day. All concessions must be off the fairgrounds by Wednesday, September 6th, 2023, unless prior arrangements have been made. All materials you bring onto the Fairgrounds must be taken with you. **Vendor Hours of Operation for the Fair are Wednesday 5 pm-11 pm, Thursday & Friday 12 pm-11 pm, Saturday & Sunday 12 pm-11 pm, Monday 9:30 am-11 pm.** Exceptions to these hours must be approved by the Fair Board.
- Concessions must be kept clean and presentable at all times, and trash must be put in proper containers. Do not put large cardboard boxes in trash cans; set them beside the trash cans. All cooking oil must be disposed of in provided containers.
- Any materials the Fair Board deems obscene, dangerous, unlawful, or otherwise inappropriate for a family-friendly environment are strictly prohibited from sales, promotion, and display, or advertised in any way.
- Merchandise, food, or other materials being sold, promoted, displayed, given away, or marketed shall be conducted within the designated space rented by the vendor.
- Vehicles may not operate on Fair property after 8 am until closing each night. **PLEASE HAVE YOUR VEHICLE PARKED BY 8 am.** Concessions must be open during the hours of the Fair. Any concession that leaves early will not be allowed to return the following year unless approval has been given for a special circumstance by the Fair Board.
- Posting of signs or self-adhering stickers will not be permitted outside of vendor's rented space.
- All merchandise belonging to anyone will be the sole responsibility of the owner. The Great Stoneboro Fair will not be responsible for any loss by theft, accident, or act of God.
- All CO2 and propane cylinders in food concessions and commercial exhibits are required to be secured with labels visible.
- Plug-in receptacles available only in the Commercial Building and under the Grandstand. All other connections are hard-wired to breaker panels. All electric boxes are locked for your safety and protection. **Your electric supply will be connected by the contractor on the grounds, and additional charges may apply for hook-up.** Electricians are available for hook ups **from 9 am to 8 pm Sunday, Monday, and Tuesday** prior to the Fair. Disconnects are available the evening of Fair closing and the following two days from 7 am to 3 pm. There will be an upgrade fee of \$50 to upgrade the breaker size after the initial installation plus the increase in breaker cost. This upgrade will be automatic after the third reset of a tripped breaker. Upgrade fees and expenses must be paid in **cash** at the **Secretary's Office** prior to the work being completed. Eliminate downtime and lost sales by choosing the right electrical hook-up when your contract is being created. For electrical questions, contact Wilson Electric at (814) 786-7545. **The Fair Board reserves the right to close any concession not complying to these rules and regulations, and all payment made to the Fair will be forfeited.**
